









Get People Back to the Office with Safe Workplace

EMPLOYEE CHECK IN/CHECK OUT WITH A SEAMLESS AND INTUITIVE MOBILE EXPERIENCE

Key fobs get lost. Cards can be easily cloned or shared. Doors can be wedged open. Some staff may travel to multiple office locations with full access; others only to a single area within one location. But no matter the scenario, Genea's standard access control dashboard allows administrators to easily define hierarchies of access by employee, location, floor, and workflow.

They can gain real-time intel on who badges in and out of a workplace; view integrated video feeds for any security breach - and define who needs to know about it; deactivate access the moment an employment relationship ends; and view activity logs in seconds. Need to grant after-hours access, hold open a door, or run an emergency lockdown? No problem - all can be done remotely. By using smartphones to control access, the incidence of shared, lost or duplicated access cards is reduced or eliminated entirely.








- Limit the number of people coming to your space on a given day
- Enforce social distancing with occupancy thresholds and alerts to help you monitor activity levels inside your building or workplace
- Integrate even further with touchless visitor management

Safety and security rely on compliance, adherence, and consistency. Safe Workplace optimizes all - in an environment driven by COVID protocols - by automating access to a workplace through fully customizable qualifications. Administrators, for example, can set capacity limits by reducing workplace capacity from 100 to 20 with a single keystroke. Employees can reserve a space in the office, answering a series of health questions to determine their confirmation or denial of access, before they ever leave home. Onsite thermal sensors can check temperatures, communicate with online access panels, and deny access if a high temperature is recorded.









Safe Workplace was designed to account for mistakes or exceptions: If an employee accidentally selects 'yes' instead of 'no' to a health question, they can request that their questionnaire be reviewed and reset. If an employee can't gain access because office capacity has been reached, they can contact HR (or the admin) for an override if it's deemed essential.

Visitors to a workplace can also be pre-registered online, asked the same set (or a new set) of health screening questions, and provided temporary access via a QR code - ensuring touchless visitor management from start to finish.






CONTACT TRACING AND SUPPORT

Give administrators and executives across departments insights on occupancy and capacity management, and facilitate contact tracing with all activity logs.

At any point, Safe Workplace users can generate reports of exactly who was granted and denied access, who checked in, who was co-located in a workplace at any given time, and when individuals left. The result of these insights is critical for contact tracing in the event of a positive COVID case; administrators can easily determine potential exposure and launch targeted contact tracing efforts immediately.
